MILTONPICS 2020 15% BONUS TERMS AND CONDITIONS

1. INTRODUCTION

1.1 Milton Markets Limited is incorporated in Vanuatu, company number 40370, and is regulated by the Vanuatu Financial Services Commission (VFSC) (hereinafter "the Company").

1.2 MILTONPICS 2020 15% BONUS is a promotion for Milton Markets clients (hereinafter "the Client").

1.3 To apply for the MILTONPICS 2020 15% BONUS (hereinafter "the Promotion"), Terms and Conditions is an integral part of the Milton Markets Terms and Conditions and provisions set herein are considered as an annex of the Milton Markets Terms and Conditions.

1.4 The Company reserves the right to decline the Promotion to any applicant who registers with false information.

2. CONDITIONS OF ELIGIBILITY

2.1. The Promotion is only available to the self trading Clients.

2.2 The Promotion may be offered by Milton Markets from July 12, 2021 to August 8, 2021 (GMT time) to clients who deposit into Smart Accounts* or Elite Accounts with the promotion code "TOKYO2020".

*Smart Accounts opened through cashback websites are not eligible for this promotion.

3. TERMS AND CONDITIONS

3.1 Clients, who meet the criteria set forth herein are able to receive trading cash equal to:

- (a) 15% on the amount of their first deposit that is made in their Smart Accounts or Elite Accounts with Milton Markets, provided that the maximum amount of any such trading cash awarded to any particular Eligible Client will be limited to a maximum amount of up to 150,000 JPY (or currency equivalent) per Eligible Client.

4. REQUIREMENTS

4.1 Clients must meet the following requirements in order to trade, transfer funds or withdraw bonus funds from this program. If the Client has not achieved the following conditions at the time of withdrawal, the granted bonus amount at the time of deposit will be deducted.

(a) Clients are required to hold the bonus for at least 90 days after receiving it. Before this period, Clients can not withdraw or transfer funds to another account.

(b) Clients must trade the required number of lots according to the formula described below.

[JPY Account] Required Lot Size = (Bonus Amount Received) ÷ 200

[USD Account] Required Lot Size = (Bonus Amount Received) ÷ 2

Example: If a Client deposits 100,000 yen, they will receive 15,000 yen.

You must have completed $15,000 \div 200 = 75$ lots in your deposit account before you can transfer funds, or withdraw the bonus amount.

5. GENERAL TERMS

5.1 In the event that a Client's trading account becomes dormant, all previously awarded bonus/credit amounts will be immediately withdrawn from the Client's account.

5.2 Partner commissions/rebates may not be generated from bonus funds.

5.3 This promotion may be used only once by any Client, unless officially approved by Milton Markets Management.

5.4 This promotion may be used together with Wire Transfer(Japan) Special Credit promotion.

5.5 Taking part in this Promotion constitutes acceptance of these Terms and Conditions set forth on Milton Markets' website.

5.6 If any of the Promotion terms were to be translated into a language other than English, then the English version of these terms shall prevail where there is an inconsistency.

5.7 The Client can receive the Promotion only one (1) time per account.

5.8 Internal fund transfers between the Client's accounts will not be considered as deposits.

5.9 The deposit immediately made after a withdrawal to the account will not be eligible for the Promotion.

5.10 The Promotion offer is non-transferable.

5.11 The Promotion cannot be combined with any other promotions running by the Company. (See exception 5.4)

5.12 If the registration data of a participant in the promo corresponds with the registration information of another participant in the promo, Milton Markets reserves the right to regard this matching as a reason for immediate disqualification.

6. OPERATING TERMS

6.1 For purposes of the Promotion, 1 lot shall be equal to 100,000 of trading units on MetaTrader 4. The Promotion is for major and minor Forex trading only. Any products besides the major and minor Forex are excluded. Trades conducted in USD/HKD are strictly excluded. Only completed transactions with profit/loss are counted.

6.2 Any indication or suspicion, in the Company's reasonable discretion, of any form of arbitrage (including but not limited to risk free profiting), abuse (including but not limited to participant's trading activity patterns that indicate that the participant solely aims to benefit financially from the the Promotion without being genuinely interested in trading in the markets and/or taking market risk), fraud, manipulation, cash-back arbitrage connected to a the Promotion or any other forms of deceitful or fraudulent activity, will nullify all previously credited Bonuses/Credits in the Client's real trading Accounts with Milton Markets and/or any and all transactions carried and/or profits or losses garnered therein. In these circumstances, Milton Markets reserves the right, at its reasonable discretion, to close/suspend (either temporarily or permanently) all such Client's real trading Account(s) with Milton Markets, cancel all orders and annul all profits of such participants. In these circumstances, Milton Markets shall not be liable for any consequences of the Promotion cancellation, including, but not limited to, order(s) closure by Stop Out.

7. DISCLAIMER

7.1 By registering for the Promotion, the Client agrees to the collection, use and disclosure of any personal information and may submit for the purposes:

- (a) of administering the Promotion and Bonus payment;
- (b) set out in these Terms and Conditions; and
- (c) set out in our Privacy Policy.

7.2 The Company reserves the right to decline Promotion payments to Promotion participants, without prior notice and in its own discretion, pursuant to these Terms and Conditions. Abusing the Bonus will lead to cancellation of the Bonus and closure of the Client's account. Promotion payments shall also be declined in the cases where:

- (a) there is a reasonable doubt that the Client is involved in activities (apparent or not) aimed at receiving and withdrawing the Bonus funds by means of placing fake deals or other scams; and
- (b) there is a reasonable doubt that the account is managed by a third party. In all other suspicious cases not covered by rules above, the Company has a right to make a decision about Bonus adding or reducing on its own.

7.3 The Company has the right to amend, alter or terminate the Promotion at its sole discretion, and at any time.

7.4 Milton Markets reserves the right, at its reasonable discretion, to discontinue the offering of this Promotion to any of its clients. Such clients will be informed via email.
