# HAPPY NEW YEAR DEPOSIT BONUS SPECIAL TERMS AND CONDITIONS

## 1. INTRODUCTION

1.1 Milton Markets Ltd operating under the trading name Milton Markets, is Registrar of Companies in Vanuatu under number: 40370 and regulated by the Vanuatu Financial Services Commission ("VFSC") (hereinafter called the "Milton Markets").

1.2 The HAPPY NEW YEAR DEPOSIT BONUS SPECIAL ("New Year Bonus") promotion Terms and Conditions is an integral part of the Milton Markets Terms and Conditions and provisions set herein are considered as an annex of the Milton Markets Terms and Conditions.

## 2. CONDITIONS OF ELIGIBILITY

2.1 Subject to, and without prejudice to, all other Terms and Conditions, the New Year Bonus promotion is available to Milton Markets' clients who have satisfied the Eligibility Criteria for the offer ("Eligible Clients") as set out in the sections following hereinafter.

2.2 The New Year Bonus promotion is offered by Milton Markets from January 1, 2021 to January 31, 2021 to clients in Milton Markets.

2.3 The New Year Bonus promotion is not allowed for persons under the age of 18 or otherwise under legal age in their country of residence ("minors"). If you are a minor, you may not participate in the New Year Bonus.

2.4 If the registration data of a participant in the New Year Bonus promotion corresponds with the registration information of another participant in the New Year Bonus promotion, Milton Markets reserves the right to regard this matching as a reason for immediate disqualification.

## 3. SPECIFIC HAPPY NEW YEAR DEPOSIT BONUS SPECIAL PROMOTION TERMS

3.1 The minimum deposit amount for this promotion is 1,000 USD (or currency equivalent) per Eligible Client.

3.2 Eligible Clients are able to receive 15% bonus in their Wallet Account(s) ("Wallet") on the amount of their deposit when they deposit with the promotion code "NEW21" in their real Account(s) with Milton Markets.

3.3 The maximum amount of New Year Bonus granted to any particular Eligible Client will be limited to a maximum amount of 15,000 USD (or currency equivalent).

3.4 Eligible Clients may withdraw or transfer the New Year Bonus when they meet the following requirements:

(a) The funds stay in real Account more than 90 days after deposit is made.

(b) Trading Volume reaches at least N lots with major and minor forex pairs.

[USD]N lots= Deposit amount\*15% / 1.5

[JPY]N lots= Deposit amount\*15% / 150

(e.g.) If the Eligible Client deposits 1,000 USD, 150 USD will be added to the Wallet. The required trading volume for withdrawal will be 100 lots for 1,000 USD.

3.5 For purposes of the New Year Bonus promotion, 1 lot shall be equal to 100,000 of trading units on MetaTrader 4. The New Year Bonus promotion is for major and minor forex trading only. Any products besides the major and minor forex trading are excluded. Trades conducted in USD/HKD are strictly excluded. Only completed transactions with profit/loss are counted.

3.6 The Profit may be withdrawn anytime after 90 days since the New Year Bonus is granted in the Wallet, provided that Eligible Client keeps funds in the real Account(s) on the same amount of deposit made for this promotion.

#### 4. GENERAL TERMS

4.1 Please note that it may take up to one business day before the New Year Bonus is granted to the Wallet of an Eligible Client who meets all of the criteria set forth herein.

4.2 The New Year Bonus promotion applies to all clients who complete the registration process with Milton Markets in accordance with the rules set herein and granted New Year Bonus may be withdrawn anytime when they meet the requirements.

4.3 Any withdrawal of funds from an Eligible Clients' real Account(s) with Milton Markets before Eligible Clients meet the requirements will immediately nullify the New Year Bonus promotion and will cause all bonus to be withdrawn from the respective Eligible Client's Wallet in Milton Markets.

4.4 In the event of internal transfers between real Accounts with Milton Markets before Eligible Clients meet the requirements, the New Year Bonus in the Wallet will be nullified.

4.5 The New Year Bonuses cannot be separately transferred between, or from Eligible Clients' Wallet with Milton Markets.

4.6 Milton Markets reserves the following rights at its reasonable discretion.

(a) The right to decline registration of any participant in the New Year Bonus promotion.

(b) The right to disqualify any participant in the New Year Bonus promotion who tampers or attempts to tamper with the operation of the New Year Bonus promotion or breaches these terms and/or any of the Terms and Conditions set forth on Milton Markets' website.

Under no circumstances shall Milton Markets be liable for any consequences of any promotions and programs cancelation or decline, including, but not limited to, order(s) closure by Stop Out.

4.8 Milton Markets reserves the right to alter, amend or terminate the New Year Bonus promotion or any aspect of it at any time. Prior notice of such changes will be given to clients and Milton Markets will post any such changes on its website and/or by email. It is recommended that participants in the New Year Bonus promotion consult these Terms and Conditions on the Milton Markets' website regularly. Please note that taking part in the New Year Bonus promotion constitutes acceptance and agreement to abide by any such alterations, amendments and/or changes.

4.9 Milton Markets reserves the right, at its reasonable discretion, to discontinue the offering of the New Year Bonus promotion to any of its clients. Such clients will be informed via email.

4.10 In the event that real Account becomes dormant all previously granted New Year Bonuses will be withdrawn from the respective Eligible Clients' Wallet with Milton Markets.

4.11 No Partner's commissions are paid for New Year Bonus while the bonus stay in the Wallet.

4.12 The deposit immediately made after the withdrawal to the accounts will not be eligible for this promotion.

4.13 Any indication or suspicion, in the Milton Markets' reasonable discretion, of any form of arbitrage (including but not limited to risk free profiting), abuse (including but not limited to participant's trading activity patterns that indicate that the participant solely aims to benefit financially from any promotions and programs without being genuinely interested in trading in the markets and/or taking market risk), fraud, manipulation, cash-back arbitrage connected to the promotions and the programs or any other forms of deceitful or fraudulent activity, will nullify all previously granted bonus of the Eligible Client's Wallets and/or real Account(s) with Milton Markets and/or any and all transactions carried and/or profits or losses garnered therein. In these circumstances, Milton Markets reserves the right, at its reasonable discretion, to close/suspend (either temporarily or permanently) all such Eligible Client's real Account(s) with Milton Markets, cancel all orders and annul all profits of such participants. In these circumstances, Milton Markets shall not be liable for any consequences of the promotion and program cancelation, including, but not limited to, order(s) closure by Stop Out.

4.14 This promotion may be used only once by any Eligible Client, unless officially approved by Milton Markets Management.

4.15 Taking part in the New Year Bonus promotion constitutes acceptance of these Terms and Conditions set forth on Milton Markets' website.

4.16 If any of the New Year Bonus promotion terms were to be translated into a language other than English, then the English version of these terms shall prevail where there is an inconsistency.
